

OFFICIAL RULES

AIDS HEALTHCARE FOUNDATION'S "ONE-MINUTE HIV TESTING IN DALLAS TEXAS" NEW VESPA GIVEAWAY SWEEPSTAKES

1. SWEEPSTAKES. The Sponsor of the "ONE-MINUTE HIV TESTING IN DALLAS TEXAS." NEW VESPA GIVEAWAY SWEEPSTAKES (the "Sweepstakes") will give away one 2013 Vespa GTS300 (the one "Grand Prize") according to the terms and conditions of these rules. The Vespa will have the design, color, and features chosen by Sponsor, and there will be no substitutions. The Sweepstakes will run from April 19, 2014 to June 19, 2014.

2. SPONSOR. The Sweepstakes is sponsored by the AIDS Healthcare Foundation.

3. ELIGIBILITY. Except as set forth below, all individuals that are, as of April 19, 2014, residents of the State of Texas over the age of 18, and have a valid Texas driver's license are eligible to participate in the Sweepstakes. The Sponsor, and its respective affiliates, subsidiaries, agencies and divisions, participating promotional partners, and each of their respective employees and immediate family members (including, but not limited to, children, parents, spouses, grandparents, and domestic partners of employees) are ineligible to participate in the Sweepstakes. The Sweepstakes is void where prohibited by law. Each individual that participates in the Sweepstakes agrees to be subject to and abide by these rules. Any deviation from these rules on the part of any participant will render that participant ineligible. All decisions of the Sponsor are final.

The odds of winning depend on the total number of entries received.**

On June 25, 2014 on or about 5:00 p.m. EST, at AHF Worldwide at 6660 Santa Monica Blvd., Los Angeles CA 90038, the Grand Prize Drawing will be held for the Vespa Giveaway one Sweepstakes Entrant. The (1) Grand Prize winner will be chosen randomly from the qualifying finalist entries the week of June 23, 2014. Grand Prize winner will be notified by phone on or before July 1st, 2014. If the winner is later disqualified, the Sponsor will randomly draw a new winner from the remaining entries.

6. PRIZE INFORMATION. Only one prize, the Grand Prize, will be awarded. The Grand Prize has an estimated value of \$6,300 based on M.S.R.P. The Grand Prize must be claimed by June 8th or the winner will be disqualified. The odds of winning depend on the number of participants. Only one entry per participant allowed.
